

# LOCATION



Horsham is an affluent market town offering an excellent living and working environment, one of the largest in West Sussex having a population of approximately 47,000 with a catchment area of approximately 250,000 inhabitants, . The town's bus station is nearby, the mainline railway station within walking distance and the town benefits from good road links, lying between the A24 to the west and A23 (M23) to the east.

The premises form part of The Forum development, situated in Blackhorse Way at the junction of and with frontage to a pedestranised walkway linking West Street and the Swan Walk Shopping Centre (Horsham's prime retailing area) to The Forum Plaza. Blackhorse Way car park is close by and nearby occupiers include Blacks, TK Maxx, Dunelm and Sainsbury's.
